### BOE Policy Use of Electronic Devices

Pupils are not permitted to use electronic devices and/or cellular telephones while school is in session. Electronic Devices/Cellular telephones must be turned off while the pupil is in the school building and may only be turned on after school has concluded for the day and outside the school building. (See handout for violations).

## **Security Vestibule**

- Access to building is granted by main office only.
- For safety and security of all, do NOT hold the door open for anyone.

- Always have photo ID available.
- When students are granted access to the building, we ask that you exit the building.

### Lunch Accounts

Breakfast and Lunch are free, reduced, or paid. If you feel you qualify for free/reduced lunch, forms should be completed. Snacks are available at a cost. Notes on your child's account can be addressed with Sodexo. Money can be kept on your child's Mealtime account.

#### CHANGE IN NORMAL ROUTINE FOR DISMISSAL

With safety and security in mind, we require adherence to your child's regular, normal mode of transportation on a consistent basis (consistency on a weekly basis: parent pick up all week, bus home all week, etc.).

If it becomes necessary to request a change in your child's dismissal procedures, this change must be presented to the school office in writing along with a follow-up phone call to the main office (sole form of electronic communication is never recommended).

Last minute changes by telephone will not be permitted and we ask that changes are kept to a minimum. Early pickups should occur no later than 3:00 p.m. during regular school days, and no later than 12:45 p.m. on early dismissal days.
